NOTICE FOR MOP-UP COUNSELING : JENPAS UG 2025

In continuation with the WBJEEB notification No. WBE/Reg- 158/25, Dated: - 13-11-2025, it is hereby notified that a mop-up counseling for the candidates who appeared in JENPAS UG 2025 examination, conducted by the WBJEEB; will be taken up by The west Bengal University of Health Sciences (WBUHS). The interested candidates for the allied health sciences courses only are hereby instructed to visit the University website and click on the Counseling tab to be navigated through the steps of online process of the counseling.

Eligibility to participate in the counseling: Candidates who were registered in WBJEEB rounds or counseling but could not be allotted any seat in any course in any college during any round(s) of counseling will be the eligible to participate in the counseling. However those candidates who did not register for the counseling conducted by the WBJEEB, despite having a valid rank card of the JENPAS UG 2025; will be given an opportunity to register afresh for this round of counseling on payment of the counseling processing fee to the WBUHS and participate in the counseling.

Registration and choice filling for Counseling: All candidates are instructed to click on the “Counseling” tab on the website of the WBUHS. They will have to log in using the personal credentials as shown on the portal. Upon successful log in into the system; the candidates will be shown the seat matrix showing the vacancy status of different types of seats in the various colleges, from which they will have to choose the course, category of seat and the college. The candidates are instructed to chose and rank as many colleges as possible from the available seat matrix to increase their probability of allotment. If the candidate has not registered into the counseling conducted by the WBJEEB; they will be redirected to payment gateway to remit the counseling processing fee of Rs. 500/- (Rupees Five Hundred only). On successful completion of payment; the candidates will be allowed to lock their choices. It is further mentioned that the counseling processing fee is not refundable under any circumstances irrespective of the outcome of the counseling. The candidates can change their choices till the time for the same is allowed and lock their choices. Otherwise the last edited version of the choices will be taken as the final ranking of the choices.

Allotment of seats and admission at the college: Candidates will be allotted seats in any course and college as chosen by the candidate according to the preferences exercised by the candidate vis-à-vis the rank obtained by the candidate in JENPAS UG 2025 examination. Candidates will require to be present by herself or himself by the last date of admission at the allotted college for physical verification of the relevant testimonials. The college authorities are requested to be extremely vigilant to authenticate the admit of the JENPAS UG 2025 examination of the candidate, the rank card obtained in that examination and the

University as a bona fide student. On successful verification of the testimonials, the candidates will be admitted to the allotted course and college through the online link provided to the college authorities. The candidates are reminded here that they must procure print copies of the allotment receipt and admission receipt generated online from the WBUHS portal which will be essential for them for registration at the WBUHS.

- Last Date of Admission at the allotted college: 19.03.2026

It is hereby mentioned that reservation has to be based on the Notifications 917-BCW/MR-33/2025 dated 8th May, 2025, notification nos. 1056-BCW/MR- 33/2025 (P. I) and 1057-BCW/MR-38/2025 dated 27th May, 2025, notification nos. 1106-BCW/MR-38/2025 and 1107-BCW/MR-38/2025 dated 3rd June, 2025 and notification no. 112/Labr/112(73)/Emp, dated -13th June, 2025. These orders are to be read with the final order / Judgment passed by Hon'ble Supreme Court of India in Special Leave to Appeal (C) No(S) 17422/2025 dated 22.08.2025 (Arising out of impugned final judgment and order dated 17.06.2025 in CAN No. 1/2025 passed by the Hon'ble High Court at Kolkata). It is to be kept in mind that the course of counseling will be bound by the directives issued from various legal institutions from time to time and may impact the process and outcome of the same including the final outcome of the SLP (c) No. 17751 – 17755 of 2024.

This is further notified that there will be no further round of counseling for the different courses under JENPAS UG 2025 examination to be conducted for the academic session 2025 – 2026 even if seats remain vacant at the end of this round of counseling. So all concerned should be alert to participate in the counseling keeping the above in mind.
